RESOLUTIONS

Affiliate members of the MGA are reminded that any resolutions or amendments to the MGA Constitution should be made in writing and reach the MGA Secretary by not later than <u>14th February 2018 at 18:00 hours</u>. Any amendments to a proposed resolution must be made in writing and handed to the MGA Secretary by the <u>21st February 2018 at 18:00 hours</u>.

The MGA Executive Council will be proposing only one motion with the purpose to amend Clause 2.4 of the Constitution as follows: **Replace the words Malta Sports Council by Sports Malta so as to read**

To develop and nurture relationships between the Association and the Maltese Olympic Committee, Sports Malta and any relevant local government departments or authorities.

ELECTIONS FOR THE EXECUTIVE COUNCIL

Elections are due for all the posts on the Executive Council. All MGA affiliate members and, that is, all Royal Malta Golf Club <u>full</u> voting members holding <u>permanent residency</u> in Malta [Maltese and foreign permanent residents holding an identity card as issued by the Government of Malta] can stand for elections with the requirement that those contesting for the post of President or Secretary should additionally hold Maltese nationality.

Should any affiliate member wish to contest any of the eligible positions for election, he/she should do so in writing to the MGA Secretary on the appropriate form provided (and available through the offices of the Royal Malta Golf Club) not later than 21st February 2018 at 18:00 hours. Any such application should be proposed and seconded by affiliate members.

Balloting will be held at the Royal Malta Golf Club on the following days:

Monday 5th March from 09:00 hours until 17:00 hours

Tuesday 6th March from 09:00 hours until 17:00 hours

Wednesday 7th March from 09:00 hours until 15 minutes after the start of the Meeting

Ballot papers will be delivered against signature, identity card number and Club's membership number.
